Notes to Associates

- As you will see from the dates listed below we run an Associate course approximately every 8
 weeks. The intention being that an Associate will have least made an application for their IAM Test,
 and may have taken this, within this period.
- Associates should be aware that once they have been allocated to an Observer it is their responsibility to keep in touch. It is in your interest to commence the on-road guidance as soon as possible after the initial course meeting to avoid overlap with the following course.
- If you find that you cannot make a previously agreed appointment please let your Observer know in good time. All our observers are volunteers and it is only courteous to keep them informed.
- If you do not keep in touch with your Observer it will be assumed that you are no longer active and the observer will be allocated to another Associate. Observers are a scarce resource and we have to utilize their time to the best advantage of the group.
- When you pass your test please let your Observer know the good news! Contrary to what you may assume the IAM do not inform the local group of the outcome, only the candidate.
- We are sure you will appreciate the expertise, time and effort that your Observer has given to you and you may to thank them personally.
